Tim Adams, NCC - informed that highways defects were being actioned. Wellspring Road had another large hole created and NCC were hoping to get the ecologist back. Discussion took place with regard to a property in the conservation area which was having works completed without the correct permission and Planning Enforcement were dealing with this. The 20mph was currently with NPLAW for the order to be written and this would be chased again. Long Lane - the highways scheme for a footway from the development was being progressed and it was understood these works would also include the flooding concerns of residents to clear the drainage gulley.

Discussion took place on the issues of a caravan which had been placed onto land belonging to a resident. Another item within the conservation area was brought to the attention of the Council and this was forwarded to Tim Adams for action by the Planning Enforcement Team.

- 7.6 Flooding along Long Lane with NCC and it was hoped the programme of works at the new development would assist with this issue.
