Minutes of the Ordinary Parish Council Meeting

- To consider apologies for absence To note and approve apologies received by the Clerk prior to the meeting All members were present.
- 2. To receive declarations of pecuniary interests and dispensations in Agenda items and individual dispensations to be authorised Grahame McCabe personal EF23/2037 Boulac Cottage and Agenda item 10.5 donation to Royal British Legion.
- 3. To approve Ordinary Parish Council Minutes 20th September 2023 It was resolved that these be approved and signed by the Chair.
- 4. Resolution to adjourn the meeting for public participation NNDC and NCC Reports (10 minutes allowance) Resolved to open the meeting to the public.

Tim Adams, *NCC* - spoke about the **20mph zone** through the village and that it was ongoing. As there were still outstanding objections with a number of villagers not withdrawing their objections the application would need to go to delegated powers. This could take up to 10 weeks.

Long Lane - the footpath was nearly complete and the balance of the tenancies are in the process of being awarded. The drainage ditch has been cleared. **Wellspring Road** - the ecologist has attended and the radar test completed. Pot holes had been reported as required.

Issues raised - *Flagship* - the trees which were planted are dying and need attention or replacing. The Clerk would write to Flagship. EP *Long Lane* cars are parking near to the village shop - which is causing issues on exiting the road. This is a Police matter and evidence would need to be provided. *Bramble Lane* had pot holes - these would be reported by the together with photos of the damage.

Roy MacDonald, NNDC - discussed the *EF 23/2037* which he was working on with the Enforcement Team and discussion took place on this matter. The Clerk was asked to write a comment on the planning number in connection with this application and the encroachment of the fencing onto Crown Loke.

Church Street - overgrown plot - this had been discussed with the Planning Department. A request would be made to maintain the boundary of the land so that it did not become overgrown.

5. To review and consider Planning if received

No new planning had been received however, it was noted that EF23/2037 relating to Boulac Cottage had been drawn to the Council's attention. It was resolved that the Clerk writes to NNDC on this application in connection with the encroachment into the Loke. This causes access issues to residents and may eventually lead to a challenge for ownership of the area which has been fenced off. EP

- 6.7 Water o/side Ham House ref 900232767 reported again 900244762 This does not meet their criteria for repair however, they will monitor the situation. A photo of the puddling would be supplied.

- **6.8** Allotments 6 new allotments leases completed invoices sent out for all allotments and funds being received. Sourcing a new water tap.
